

BIG GREEK GETAWAY SWEEPSTAKES

OFFICIAL RULES – NO PURCHASE NECESSARY

TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES AND D.C., 21 YEARS OF AGE OR OLDER.

VOID IN ALASKA, HAWAII AND WHERE PROHIBITED.

1. How to Enter: Beginning at 10:00 a.m. Eastern Time (“ET”) on April 24, 2019 until 9:00 p.m. ET on June 21, 2019 (the “Promotion Period”), you may enter The Big Greek Getaway Sweepstakes (the “Promotion”) the following way:

(i) **In Stores:** By hand printing your name, complete address, phone number (including area code) and date of birth on a postcard in any of the 4 Big Greek Café Locations. Mechanically reproduced or pre-printed entries generated by script, macro or other automated or mechanical means and entries by any means which subvert the entry process will not be accepted. Mechanical stamping machines are acceptable. Incorrect, illegible, corrupt, and incomplete entries are void.

Incorrect and incomplete entries are void. These official rules are also available at the Website.

All entries must be received by the end of the Promotion Period to be valid. There is a limit of one (1) entry, per eligible person, per day. For purposes of this Promotion, a “day” begins at 12:00 a.m. ET and ends at 11:59 p.m. ET unless specified otherwise. If multiple entries are received in a day, only the first entry will be accepted and additional entries will be disqualified. Any attempt by you to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or any other methods may void your entries and you may be disqualified from the Promotion.

2. Eligibility: This Promotion is open only to legal residents of the 48 contiguous United States and D.C. who are 21 years of age or older as of the Promotion start date. Void in Alaska, Hawaii and where prohibited. Employees and members of their households and immediate families (spouses, parents, siblings, children and each of their respective spouses) of the Promotion Entities (as defined below) and their respective parent companies, subsidiaries, and affiliates, and their advertising and promotion agencies and all local sponsors are not eligible.

By entering, you agree to release, discharge, indemnify and hold harmless the Promotion Entities, and their respective parent companies, subsidiaries, their respective representatives and agents, advertising and promotion agencies, promotion partners and prize

suppliers, and all of their respective affiliated companies, employees, officers, directors and shareholders, from and against all claims and damages or liability arising in connection with your participation and/or entry in the Promotion and/or your receipt or use of any prize awarded in this Promotion or due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any Promotion-related activity or participation in this Promotion. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

5. How Winner will be Determined: One (1) potential Grand Prize Winner (the "Grand Prize Winner") will be selected in a random drawing from among all eligible entries on approximately June 22, 2019, and will be contacted by phone or email on or about three (3) business days following the drawing. Sponsor's decisions with respect to the Grand Prize Winner, these Official Rules, and all other matters pertaining to the Promotion shall be final and binding. The prospective Grand Prize Winner may be required to sign an affidavit of eligibility and release of liability and publicity (where permitted), and return same, properly executed, within five (5) days of issuance of prize notification. If Sponsor is unable to contact the prospective Grand Prize Winner within three (3) days from first notification attempt, if the prospective Grand Prize Winner fails to complete and return all requested forms by the specified date, or if the prospective Grand Prize Winner fails to comply with any of the requirements, his/her prize will be forfeited and an alternate prospective winner shall be selected. 6. Conditions of Entry: Entry materials that have been tampered with or altered are void. If, in the Sponsor's opinion, there is any suspected or actual evidence of tampering with any portion of the Promotion, the Sponsor reserves the right at its sole discretion to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify, suspend, or terminate the Promotion, or to conduct a random drawing to award the prizes using all eligible, non-suspect entries received as of the termination date. Should the Promotion be terminated prior to the stated expiration date, notice will be posted on the Website.

7. Prize: The Grand Prize Winner will receive the following (the "Grand Prize"): a trip for two (2) consisting of: (i) round-trip coach class airfare for Grand Prize Winner and one (1) guest to and from Athens, Greece from the major U.S. airport nearest Grand Prize Winner's residence within the 48 contiguous U.S. (as determined by Sponsor in its sole discretion);

The specifics of all aforementioned elements of the Grand Prize in the Promotion shall be solely determined by Sponsor and Prize Provider. All costs, taxes, fees, and expenses associated with any element of the Grand Prize not specifically addressed above are the sole responsibility of the Grand Prize Winner. Winner's responsibility. Grand Prize Winner will be issued a 1099 tax form for the actual value of the Grand Prize.

Any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, shall be resolved individually, without resort to any form of class action. You agree to service of process by mail or other method acceptable under the laws of the State of Maryland.
